the academic year 2023-2024 in the orders 6th cited.

The Mandal Educational Officer, Palakol Mandal in reference 9th cited, has
forwarded the proposals for according Recognition to Bharatiya Vidya Bhavan's
Greenfields School, Vadlavanipalem, Palakol, Palakol Mandal for classes I to V for the
period from 2023-2024 to 2030-2031. The inspecting Officer and Mandal Educational
Officer, Palakol Mandal has verified the application for Recognition with reference to the
conditions laid down in the references cited and caused inspection and submitted his
report.

After careful examination of the proposals from the society, the inspection report
of the inspecting officer and also rules in force in the references cited, **Recognition is**
hereby accorded to Bharatiya Vidya Bhavan's Greenfields School, Vadlavanipalem,
Palakol, Palakol Mandal for **classes I to V** for the period from **2023-2024 to 2030-2031**
without aid, subject to the following conditions:

1. That the permission/Recognition accorded is valid for mentioned school building,
address, Classes, medium and the period only. If the school building and/or address
changed and/or other classes and/or medium opened without proper permission
from the competent authority, the permission/recognition will be cancelled without
prior notice.
2. That the society shall abide by the instructions, rules and regulations made by the
Government and/or District authority from time to time.

3. That the Educational Institution shall serve the needs of the locality more particularly and shall adopt the curriculum and syllabus prescribed by the Government from time to time, i.e., that the school timings, vacations and mid-term holidays shall be maintained as prescribed by the Government and/or District authority from time to time.
4. That the qualified staff, within the age limits and qualifications prescribed by the Government for Government Employees shall be followed and, shall be appointed as per the staff pattern and should be provided sufficient facilities and the results of the institution shall be satisfactorily every year.
5. That the Records, Audit Report, Administrative Report and list of Governing body of the Educational Society shall be furnished through concerned Inspecting Officer to the District Educational Officer, West Godavari, every year by 30th September at the latest.
6. That the pay / fee structure fixed by the Governing body shall be got approved by the District Educational Officer, West Godavari, every year.
7. That all the conditions prescribed in the RTE Act, 2009, and Government orders from time to time which are not specified in these orders shall also be complied with.
8. That the school shall not be closed without giving intimation both to the parents and District Educational Officer/ competent authority at least 6 months before and also obtain the permission from the concerned authorities to close the school before the date on which summer vacation is declared.
9. That the society shall submit the proposals for renewal of recognition in proper manner in advance i.e., at least 6 months prior to the date of expiry i.e., 31st October of the present recognition if the Management has failed to submit the proposals within stipulate time they should not opened the school without prior permission of the department.
10. That School have the complaint box to receive the complaints from the students as per the instructions issued in this regard.
11. That the society shall provide fire safety measures in the school as per the No Objection Certificate.
12. The Management informed that no thatched roof accommodation is allowed to run the School.
13. Proper and adequate Toilets/ sanitation facility shall be provided for students especially for girl students.
14. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
15. The school shall follow the traffic and safety guidelines indicated by the Police and Fire services departments.

16. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
17. The school shall have first aid kit and the teachers shall be trained in first aid.
18. The Correspondent of the concerned school is hereby informed to file an affidavit to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
19. That the Management has to maintain trained teachers at all time.
20. That the Management is informed to follow the guidelines issued in G.O.Ms.No.53 School Education PS, Dated. 24.08.2021 regarding Fee Structure in Private Schools.
21. That the Management of the school is informed that, these order are issued subject to conditions that, to obtain and submit the occupancy Clearance of fire issued by the concerned department within the stipulate dates mentioned in the order and submit to this office through the inspecting officer concerned for the intire period of recognition without fail. If the management fails to comply with the above conditions promptly, the Recognition now granted will be reviewed.
22. Where aver the pupil ratio (as per rule 10 (12) of G.Ms.No.1 Education (PS-2) dt.01-01-1994) increases on or before i.e., 31 August of ever year the Management should obtain permission for additional sections from the concerned authorities by the end of September of the same academic year.
23. That the Management should not ask any grant from the Government or Department now or in future and that corporal punishments should not be awarded to the children and abide to the Child Rights without fail.
24. In any deviation on the specified conditions herein and also the Government orders from time to time, action will be taken to cancel the Recognition.
25. That the management should submit Structural Soundness Certificate every year before opening of school.
26. The Management should admit children's under 12 (1) c as per Govt. norms and time to time instructions of department.

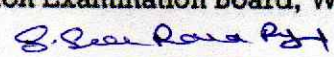

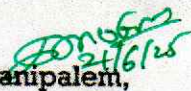
